SIXTH WITNESS STATEMENT
OF HOLLY STEBBING

I, Holly Stebbing of Norton Rose Fulbright LLP, 3 More London Riverside, London SE1 2AQ, United Kingdom, state as follows:

1 Introduction

- 1.1 I am a Partner at Norton Rose Fulbright LLP (**NRF**). I am duly authorised to make this witness statement on behalf of the Claimants.
- 1.2 The facts and matters set out in this statement are within my own knowledge unless otherwise stated, and I believe them to be true. Where I refer to information supplied by others, the source of the information is identified; facts and matters derived from other sources are true to the best of my knowledge and belief.
- 1.3 There is now produced and shown to me a paginated bundle of true copy documents marked [**HS6**]. All references to documents in this statement are to **Exhibit HS6** unless otherwise stated.

2 Warning Notices

- 2.1 On 20 June 2025 I provided my fifth witness statement in this case. In my fifth witness statement I stated at paragraph 9.2 that the Claimants had identified that some of the Sites only had two Warning Notices instead of the four required, but that all sites had four Warning Notices by February 2024.
- 2.2 This statement was based on the Claimants' understanding at that time based on internal emails that were also provided to my firm. An associate in my team tried to check the position with the Claimants before I signed my fifth witness statement but the individual who has been organising service at the Sites on behalf of the Claimants was on personal leave at the time and the associate was unable to reach her. She has now returned to the office and with greater access to the Claimants' documents we now understand the previous understanding was mistaken and the Sites likely did have four Warning Notices before February 2024 with some exceptions, as set out in this statement.
- 2.3 The Claimants provided to NRF by 13 June 2024 photographic evidence of four Warning Notices at all of the Sites, as described in my third statement and exhibited thereto. This was for the purpose of the 2024 annual review hearing.
- 2.4 Before this, the Claimants did not collect photographic evidence of the Warning Notices for the purpose of evidencing service. However, in the third witness statement of Nawaaz Allybokus dated 22 April 2022, Mr Allybokus states that he had been informed there were four Warning Notices in place at each of the Sites as of 22 April 2022 (although he did not provide photographic evidence).

- 2.5 The Claimants have evidence of 40 Warning Notices being purchased in July 2023 after the order of Linden J dated 18 June 2023 amended the wording of the Warning Notices. Five were sent to each of the then eight sites, 20 being sent directly to Hythe, with five to be transmitted onwards to each of Alton, Hartland Park and Fawley. **[HS6/5]**
- 2.6 When the wording of the Warning Notices was changed as part of the order of Ellenbogen J dated 29 January 2024, 28 new Warning Notices were ordered (four for each of the by-then seven Sites) and delivered to each of the Sites (with 12 Warning Notices being delivered directly to Hythe, with four to be transmitted onwards to each of Alton and to Fawley). **[HS6/16-17, 18]**
- 2.7 When the photographs were being taken ahead of the 2024 annual review the Claimants discovered that Avonmouth only had two Warning Notices, Alton only had two and Purfleet had a damaged Warning Notice. The Claimants therefore ordered seven new notices on 11 June 2024:
- (a) Two Warning Notices were sent to Hythe for onward transmission to Alton as it is unstaffed.
 - (b) Four were sent to Avonmouth (two to replace the two that were missing and two as spares as Avonmouth is beside the sea and the Warning Notices were prone to being damaged).
 - (c) The final Warning Notice was sent to Purfleet. **[HS6/11-12]**
- 2.8 The previous confusion arose from emails that suggested new Warning Notices had been ordered because the Sites did not have enough Warning Notices in February 2024. However, upon further investigation it transpires these new Warning Notices were ordered because the wording of the Warning Notice changed as part of the order of Ellenbogen J dated 29 January 2024.
- 2.9 Based on the lack of photographic evidence before June 2024, the Claimants cannot definitively say if four Warning Notices were at the Sites at all times before June 2024 (otherwise than described above). As explained at paragraph 9.1 of my fifth witness statement, the Claimants now conduct monthly checks to make sure Warning Notices and containers are in place.

3 Additional evidence of continued threat

- 3.1 Since my fifth statement, I have become aware of further evidence that supports my fifth statement. At paragraph 3.7 (c) of my fifth statement I referred to undercover reporting by GB News of an alleged recording of Just Stop Oil saying in fact it had

not disbanded. This was reported on 16 May 2025 and on 21 May 2025 Just Stop Oil emailed its mailing list stating “GB News was *right for once*. We are “*plotting a very big comeback*”.” It also suggested the comeback may not be in the name of Just Stop Oil but be closely aligned to the campaign, stating that:

“Just Stop Oil was just the beginning. A new campaign is in the works—one that will build on our knowledge and success as Just Stop Oil and will face the grinding injustice of our political and economic system head on. We're just getting started.”
[HS6/23-24]

STATEMENT OF TRUTH
